

2009


• COP XV - Brazil presents its voluntary commitments to reduce emissions, including reduction of 80% in the Amazon and 40% in Cerrado.

2010

- Wide debate promoted by the House of Parliament on the PL 5.966/2009 that aimed on the creation of certified emissions reduction from deforestation and degradation.
- Civil society launched the public consultation on the REDD+ social and environmental principles.
- Ministry of Environment coordinates participatory discussion on the landmarks of REDD+ regime in Brazil.
- Brazil is selected as a FIP pilot country.
- Brazil is selected for co-chairmanship of REDD+ Partnership.


BRAZIL GHG EMISSIONS

Participações Setoriais nas Emissões Brasileiras de GEE





Evolução das Emissões Brasileiras de GEE por Mudança do Uso da Terra e Florestas (Tg CO2-eq GWP-AR2)




DEFORESTATION RATE IN THE AMAZON

 National Policy on Climate Change

Institutional

- Voluntary commitments presented at the UNFCCC (36,1 a 38,9%):
- 80% emissions reduction in the Amazon(20,9%)
- 40% emissions reduction in Cerrado (3,9%)
- Low carbon agriculture(4,9 a 6,1%)
 Green steel (0,3 a 0,4%)


Institutional (Financial)

- Amazon Fund (international contributions)
- Climate Change Fund (mainly domestic funds – up to 6% of oil industry taxes revenue)



Political

- Interministerial Council for Climate Change (CIM)
- Wide dialogue with civil society and Parliament.
- Strong mobilization of civil society, including the public consultations for the REDD Social and Environmental Principles.
 Strong mobilization of sub-national governments.

- To finalize FIP strategy.
- To formalize all needed institutional reforms for a REDD+ regime.
- To adjust the financial arrangements for REDD+.
- To have the Brazilian REDD+ regime and REDD+ strategy approved by the end of 2011.

REDD Challenges


- Reference Levels considering the 5 different biomes.
- Monitoring systems for all national forest cover.
- To build a negotiated strategy at all levels.



REDD Challenges
