## 森林保全を通じた気候変動緩和策/REDD+の協力方針 Climate Change Mitigation and REDD+ Cooperation Policies

- 我が国の政策: 開発協力大綱 重点分野 Japan's policy: Priority area in fundamental principles of development cooperation
- 気候変動対策·森林等自然資源保全等による地球規模課題への取組を通じた持続可能で強靱な国際社会の構築
- Building a sustainable and strong society through activities addressing global issues by implementing climate change measures, conserving forests and natural resources, etc.
- JICAの方針: 第4期中期計画(2017-2021)·SDGsへの貢献
  JICA's policy: Contribution to the JICA's fourth medium-term plan (2017-2021) and SDGs
- 途上国によるGHG削減貢献約束(NDC)等を踏まえ、民間資金も活用した、パリ協定への対応を含む気候変動対策の 支援。特に、気候変動に関する政策・制度の改善、森林・自然生態系の保全や管理の強化等。
- Supporting climate change measures including actions for meeting the Paris Agreement on the basis of GHG Reduction Contribution Commitment (Nationally Determined Contributions (NDCs)) of developing countries, considering utilization of private sector; particularly, improving policies and institutions related to climate change, enhancing conservation and management of forest and natural ecosystems.
- SDGs13 気候変動対策と15 森林保全等の達成をリードし、国内の知見の活用・パートナーとの連携・イノベーションにより支援を加速。
- Leading the achievement of SDGs 13 climate change measures, SDGs 15 forest conservation, and accelerating support by utilizing Japanese knowledge, cooperating with partners, and innovation

Policy 1: Contribution to achievement of national development policies and international commitments in developing countries (support for strategic regions, countries, and fields)

Policy 3: Global-level contribution and enhancement of development impact by external funds and partnership

#### なぜJICAがGCF業務に取り組むのか? (2017年より認証機関に) JICA's circumstance related to GCF (GCF Accredited Entity since 2017)

Necessity of resource mobilization for the low-carbon / climate-resilient infrastructure, while ODA budget is limited

• 日本としての貢献 Accountability to Japanese taxpayers and visible contribution to GCF 日本政府は初期資金動員で15億ドル拠出、第1次増資でも最大15億ドル拠出予定。日本の認証機関はJICAと三菱UFJ銀行。贈与(grant)案件を実施できるのはJICAのみ。

Contribution of USD 1.5 billion for the initial resource mobilization (IRM) period (2015 - 2018)

Pledged up to USD 1.5 billion\* for the 1st replenishment period (2020-2023) at the 1st High-Level Pledging Conference in Oct. 2019 (\*subject to approval of the Diet)






